

# Programme

While the initial focus of dedicated initiatives to support researchers at risk is on immediate safety, the issue of long-term socio-professional integration is equally crucial. A significant portion of the scientists at risk may not be able to safely return to their home countries. As highly skilled individuals with unique expertise and perspectives, they bring a significant value to their host countries.

However, opportunities for permanent academic positions can be limited. The private sector, NGOs, and international organizations offer promising alternatives, leveraging their unique skills and experiences. By bringing together diverse stakeholders, the 2025 Inspireurope+ Forum aim to identify opportunities, address challenges, and explore innovative solutions to facilitate the integration of researchers at risk into the broader professional landscape.

## Opening Session Speakers



**Thomas Römer** has been a Professor at the Collège de France since 2007 and currently serves as its Administrator, a position he has held since 2019. A scholar of the Hebrew Bible and its contexts, he previously taught at the Universities of Geneva and Lausanne. He is the author of numerous scientific publications and is a member of the Académie des Inscriptions et Belles-Lettres.



**Philippe Baptiste** is the Minister for Higher Education and Research in France. He holds a PhD from the University of Technology of Compiègne and is a civil engineer graduate of Mines de Nancy. His extensive career includes research at CNRS and IBM, teaching at École Polytechnique, leadership roles at the Ministry of National Education and the CNRS, and prior to his ministerial role, he served as President of the French Space Agency (Cnes).



**Philippe Aghion** is a Professor at the Collège de France and INSEAD, and a visiting professor at the London School of Economics. A leading scholar in growth and innovation economics, he notably pioneered, with Peter Howitt, the Schumpeterian growth paradigm. His research examines the design of growth policies and the role of the state. He has received several prestigious awards, including the Yrjö Jahnsson Award and the BBVA "Frontier of Knowledge Award" for "developing an economic growth theory based on the innovation that emerges from the process of creative destruction.



**Claire Morel** is the Head of Unit in charge of the Marie Skłodowska-Curie Actions for the mobility and training of researchers including the development of excellent doctoral programmes, at the European Commission's Directorate General (DG) for Education, Culture, Youth and Sport. Before that, she was the Head of Unit for international cooperation in the same DG, with a particular focus on the international dimension of the Erasmus+ programme and international policy dialogues in higher education and youth issues with various partners of the EU in the world.



**Laura Lohéac** has been the Executive Director of PAUSE since May 2017 and President of the Association Marianne for Human Rights Defenders since December 2021.

As an expert in international issues, Laura Lohéac held several positions in French administration, including the Ministry of Europe and Foreign Affairs, the Ministry of Defence, and at the office of the Secretary of State for Higher Education and Research, where she established PAUSE.

## Panel 1 Speakers



**Konstantinos Tararas** works as programme specialist for UNESCO's Inclusion, Rights and Intercultural Dialogue Section in Paris, contributing to a wider range of the Organization's human rights-related activities. Highlights include the promotion of a human rights-based approach in UNESCO programming and efforts towards the normative clarification of the right to share in scientific advancement and its benefits. He currently leads work under UNESCO's Programme and Call to Action on Freedom and Safety of Scientists.



**Clarisse Angelier** helped create the first public-private economic interest grouping (GIE) bringing together Cnam, PSA and Renault in 2000. In 2011, she set up an annual competition to encourage Cifre doctoral students to create their own company. This competition was also organised in Australia (2016, 2017) and India (2017). In 2016, she became the first woman to head the Association Nationale de la Recherche et de la Technologie (ANRT) since its creation in 1953.



**Svetlana Dimitrova** works as a Project Manager at Sofia University "St.Kliment Ohridski". She coordinates national EURAXESS, is devoted to EURAXESS Science4Refugees initiative on European level and leads an international EURAXESS team working on the process of training mentoring and integrating the refugee and displaced researchers in Europe.



**Andreina Garcia Reyes** is a research engineer specializing in marine geophysics. She holds PhD in Earth and Environmental Sciences from the Institut de Physique du Globe in Paris. Committed to bridging science and society, she co-founded the Rencontres Sciences, Art et Société initiative. She also organizes the videoconference series "Diaspora and Democracy, the ways of action."



**Myriam Hayatou** is the International Director of Science Programs at the Fondation L'Oréal. From market finance to geopolitics and managing I5+ social impact projects at the World Bank in Latin America and Sub-Saharan Africa, she also holds a degree in Neuropsychology from Berkeley University of California.

# Panel 2 Speakers



**Frank Geary** is Director of Scholars At Risk Europe, the European office of the global Scholars at Risk network hosted at Maynooth University in Ireland. SAR Europe is the coordinating partner of the Inspireurope+ project. Frank has built a career dedicated to civil society, human rights, education & culture. He was Director of IDEA, Ireland's national network for global citizenship education. At PEN International he supported the development of networks and programmes for human rights and freedom of expression in over 70 countries. Frank has advocated for education and civil society to the United Nations, European Union, and national governments.



**Liz Awad** is a former laureate of the PAUSE programme at the Collège de France. She defended her thesis in Business Management in October 2024 at Cnam Paris, under the supervision of Marie-Astrid Le Theule and Madina Rival. She left Lebanon in 2021 to pursue research on corruption. Her thesis is entitled "Stories of Civil Resistance to Crises in Lebanon: Public Management, Parrhesia, and Moral Entrepreneurship." In 2025, she received the Anticor Ethics Award in the research category.



**Mursal Dawodi** is a computer scientist and AI researcher focusing on natural language processing (NLP). Dr. Dawodi is a PAUSE alumni and received the 2023 L'Oréal-UNESCO "For Women in Science" Special Prize. She is also a High Impact Ambassador for Women in Data Science (WiDS) and an ambassador of Google Women Techmakers. She's currently a PSI scientist fellow at the Technical University of Munich. She is known for her advocacy for displaced women in STEM and mentors young scholars, particularly from Afghanistan. She is the founder of FemsTech, a non-profit organization supporting women in technology.



**Egemen Oezbek** is the academic coordinator of Academy in Exile at TU Dortmund, where he supports scholars, journalists, and cultural producers at risk to continue their work in Germany. He is also a researcher specializing in the politics of memory, with a particular emphasis on the Armenian Genocide and commemorations.

**Kristina Berkut**, is International Cooperation Manager at Association Bernard Gregory, where she connects researchers with companies and supports their transition into non-academic careers. With a PhD in Intercultural Management and a background in journalism, communication, and modern literature, she helps international researchers with non-linear paths take confident steps toward a well-considered career plan.



**Antoine Maire** is the co-founder of SELDON Conseil (France), a consultancy specializing in foresight, innovation, and social acceptability. He holds a Ph.D. in Political Science (Sciences Po/CERI). He has deep expertise in geopolitical dynamics in Northeast Asia, particularly Mongolia, and has worked with the French Ministry of Armed Forces. Passionate about science and technology, he strives to integrate social sciences into organizations' innovation strategies.



**Dr Saeedeh Rezaee Vessal** is an Associate Professor of Marketing and Head of the Digital Marketing Department at EMLV Business School in Paris. She holds a PhD in Marketing from Université Grenoble Alpes and specializes in behavioral psychology, consumer behavior, and patient experience. With several years of experience in different business schools, she has developed a deep understanding of the private higher education sector.



**Dominika Foretek**, is a former researcher in molecular biology and a strong international background. She successfully navigated a diverse academic journey from engineer degree in Biotechnology to PhD in Biochemistry and postdoctoral research at Institut Curie & Pasteur. Passionate about mentoring and career development of young scientists, as International Cooperation and Training Officer at ABG actively contributes to initiatives that enable early career researchers to explore diverse career paths.



**Patricia Layec** did her PhD in Telecommunication in partnership between the University of Paris-Sud and Orange. In 2009, she joined Alcatel-Lucent (now Nokia), first working in the business division, then joining Nokia Bell Labs. Since 2016, she is head of the Physics of Optical Networks research team.



**Sonja Kühn**, did a PhD in Biochemistry and Structural Biology at the Max Planck Institute of Molecular Physiology. She advanced her expertise through research experiences at the European Molecular Biology Laboratory, University Paris-Sud and Institut Pasteur. After leading the Protein Sciences team at Galapagos, she joined Servier in 2023 where currently she is Head of Structural Biophysics and Computational Chemistry.

**Oksana Seumenicht**, is a Ukrainian-born physicist and radiobiologist. She held key roles at the Max Delbrück Center, where she developed international PhD programs and now works in strategic research cooperation. As Managing Director of the German-Ukrainian Academic Society, she actively fosters academic collaboration between Germany and Ukraine.



**Clara Malkassian**, is a clinical psychologist who specialized as an intercultural trainer, with a strong focus on inclusive and non-formal methodologies. In addition to her role, she brings extensive experience in European project management in fields ranging from education and mental health to intergenerational learning and inclusion.



**Sarah Blichfeldt**, is an International Relations Officer at University of Gothenburg's International Centre. She is the university's SAR-coordinator, and responsible for the secretariat of SAR-Sweden.



**Omid Hashemi**, artist and former PAUSE laureate is the founder of the Rekhneh collective in Iran. He integrates a multidisciplinary approach in his practice, driven by a committed research interest in alternative lifestyles and low-tech solutions. Currently pursuing his artistic research within the "Scènes du monde" laboratory at Université Paris 8, Omid conducts visual anthropology work, including a documentary on the Zagros nomads.



**Christian Rolando**, is an emeritus senior scientist at the University of Lille and former Deputy Director at CNRS Chemistry. His research covers analytical/physical organic chemistry and now focuses on advanced FT-ICR MS, microfluidics, and Cultural Heritage analysis. He also coordinated the EU\_FT-ICR\_MS infrastructure.



**Bayan Almasri**, is a Syrian postdoctoral researcher at the University of Lille, working at the MSAP laboratory. She develops innovative protocols for the depolymerization and analysis of insoluble polymers. As the industrial and academic relations manager of the Youth Club of the French Society for Mass Spectrometry (CJSM), she has played key roles in organizing scientific events, conferences, and training sessions at national and European levels.

## Workshop 4 Speakers



**Henriette Stoeber** is a Senior Policy Analyst in the European Universities Association's Higher Education Policy Unit (EUA). She is in charge of EUA's activities for students and researchers with an at-risk background. She also oversees all quantitative research projects of the Unit and works on policy issues in the EHEA and in Erasmus+. Prior to joining EUA, Henriette has worked at the Hungarian Rectors' Conference and the German Academic Exchange Service (DAAD).



**Michael Gaebel** is the director of the Higher Education Policy Unit, which focuses on issues related to higher education learning and teaching, including the Bologna Process, lifelong learning, and internationalisation and global dialogue. Before joining EUA, Michael worked in higher education cooperation and development in the Middle East, the former Soviet Union and Asia. From 2002 to 2006, he was the European Co-Director of the ASEAN-EU University Network Programme (AUNP) in Bangkok.



**Sarah Willcox** oversees Scholars At Risk's internal operations and programming, including SAR's protection, advocacy, and university relations efforts. Prior to SAR, Sarah directed the IIE Scholar Rescue Fund serving 15 years from its year of inception to develop the program. For over twenty years she has advised in the establishment of scholar protection programs and has served on the steering committees of various advocacy organizations including the GCPEA and the UARRM.



**Joanne Pagèze** is Vice-President for Internationalization at the University of Bordeaux and is a lecturer at the Département Langues et Cultures. She has a research interest in international learning and teaching, language policy and higher education internationalization, publishing in the field of English for academic purposes, multilingual learning and internationalization. She is fully engaged in development of the European University Alliance, ENLIGHT. She is also actively engaged in European associations that support higher education internationalization, and is a member of the board of the EAIE.

**Dr. Maïke Didero** is a human geographer specialized in migration research and urban geography with a focus on Germany and the Middle East. She has been working as a programme director at the Alexander von Humboldt Foundation in the Division Middle East and North Africa since 2016. Since 2023, she is also part of the Humboldt Foundation's Division Philipp Schwartz Initiative and Academic Freedom and has been contributing to the EU-funded project Inspireurope+ (Initiative to Support, Promote and Integrate Researchers at Risk in Europe). In 2024, together with project consortium colleagues from PAUSE, the French programme for at-risk scholars, she co-authored an updated report on National Level Initiatives for Researchers at Riks in Europe.

**Frank Albrecht** leads the 'Philipp Schwartz Initiative and Freedom of Science' Division at the Alexander von Humboldt Foundation. He has been involved with the Philipp Schwartz Initiative since its inception in 2015. Before that, he worked in strategic planning and the regional department for North America, Australia, New Zealand, and Oceania at the Humboldt Foundation. Earlier in his career, he also held a position at a consulting firm in the United Kingdom



**Pascale Laborier** is Professor of Political Science at the University of Paris Nanterre/Institute for Social Sciences of Politics (ISP) and Associate Researcher at the Centre Marc Bloch in Berlin, Fellow at Migrations Convergences Institute. Her work focuses on forced academic migrations, academic freedom, and policies for rescuing endangered researchers. She recently co-edited the book "Academics in a Century of Displacement" (Springer, 2024) with Leyla Dakhli and Frank Wolff. Currently, she is involved in UXIL (Universités en exil) at Campus Condorcet.

# Master of Ceremony



**Firat Ilim** is a scholar in carnival studies and musical aesthetics. He worked as an academic for over ten years in Turkish Kurdistan, and worked as a visiting scholar at the Free University of Berlin and at IVIC of Venezuela. He completed his PhD on Mikhail Bakhtin and also published books on Giordano Bruno and Sigmund Freud.
